Applications have been made for the 408,859 new Ordinary Shares to be admitted to trading on AIM ("**Admission**"). It is expected that Admission will occur at 8.00 a.m. on or around 2 August 2022.

The total number of Ordinary Shares in issue following Admission will be 452,270,295. The Company holds 1,426,219 Ordinary Shares in treasury. Therefore the total number of Ordinary Shares with voting rights in the Company will be 450,844,076.
